## Betting and possible consequences

There will be betting on offer from this event. Betting is however not allowed to be made by players or officials connected to the event either in person or through a third party. Participants may therefore not make bets on the Event or procure through third parties the making of bets with a betting agency. Participants who, in violation of this prohibition, nevertheless make or procure through third parties the making of bets with betting agencies shall be immediately disqualified from participation in the Event and are liable for legal prosecution. Similarly manipulation of games will be met with disqualification and possible legal prosecution. Any violation mentioned above is also a breach of Player's Code of Conduct (Art. 5.2.) and will be sanctioned by BWF.
