Entry fees Singles: 45 Euro per player, Doubles: 35 Euro per player/event

The entry fees must be paid at the same time as the entries are submitted. The entry fees will not be refunded in the event of a withdrawal. In the case that the entry fees have not been received before the draw is made then the players are not in the draw. Or if in accordance with the Organizer they are allowed to pay at the tournament this must be done before their first scheduled match, failure to do so mean that they will not be allowed to play.

The Member Association that enters a player into a Circuit tournament is responsible for paying the entry fees for that player.

For all the players withdrawing in the time between the entry and the beginning of the Tournament the Organisers can invoice the entry fee to the relevant Member Association.

Entries must be submitted not later than:

- Tuesday 11th April 2017 at 23:59 BWF HQ time (GMT +08:00)
- 17:59 Local time for tournament organiser (CEST)

It is required that every event in a particular BEC Elite Circuit tournament has at least 8 competitors (i.e. actual competitors, not merely entries). If the required number of competitors is not met, this particular event shall not count towards any ranking, i.e. BEC Elite Circuit Ranking and BWF World Ranking. In accordance with regulation 10.4 in Appendix 6 to BWF's General Competition Regulations, an event must contain at least one entry from a Member Association other than the hosting Association. If an event does not contain at least one entry from a Member Association other than the hosting Association, this particular event shall not count towards any ranking. BADMINTON EUROPE is not liable for any costs incurred by third persons (players, coaches, umpires, team managers etc.) because of an event not having enough competitors to count for the rankings.

Players can not be entered unless they already have a BWF ID-number. In case you wish to enter players who do not have a BWF ID-number, please contact the BWF office well in advance of the tournament, so that the players concerned can get a BWF ID-number before the closing date of the tournament.

No late entries will be accepted.

Organizers are allowed to refuse entries if players have outstanding fees from a previous year.

Last day of withdrawal without penalty – **23 April 2017** Any player not showing up at the tournament, without having been withdrawn in advance, renders the Member Association concerned liable to an additional amount of US\$ 500,00 for the inconvenience caused by the "no show" (as defined in BWF General Competition Regulations).

Competitors must be prepared to play at the times determined for the events for which they have entered. Competitors will be scratched if not ready to play when called.

Players shall not plan their departure less than two (2) hours after their last match is planned to conclude. If a player is unable to compete due to early departure, he/she will be penalised by removal of Elite Circuit ranking points and shall not be awarded prizes or prize money. BADMINTON EUROPE shall propose to BWF that the gained BWF ranking points are also removed. (Regulation 9.5 in Badminton Europe's Circuit Instructions)

Clothing and

- Advertising Advertising on clothing and color of clothing are regulated by BWF Competition Regulations 19 to 23 and Badminton Europe Elite Circuit Regulation 18. In applying these regulations, the decision of the referee shall be final. The name on the back of the shirts is mandatory for all matches at all times during play in both the qualification and the main draw. - A player failing to wear the name on the back of his/her shirt when mandatory shall be penalised by an administrative fine of 100,00 EUR. It is mandatory - that partners in doubles wear the same colour of the T-shirt and shorts/skirts at all time during play in both the qualification and the main draw. Failing to do so shall result in an administrative fine of 100,00 EUR.
- **Insurance** The organizer declines responsibility and covering of costs for possible injuries or other damages. It is up to each participant to insure himself.
